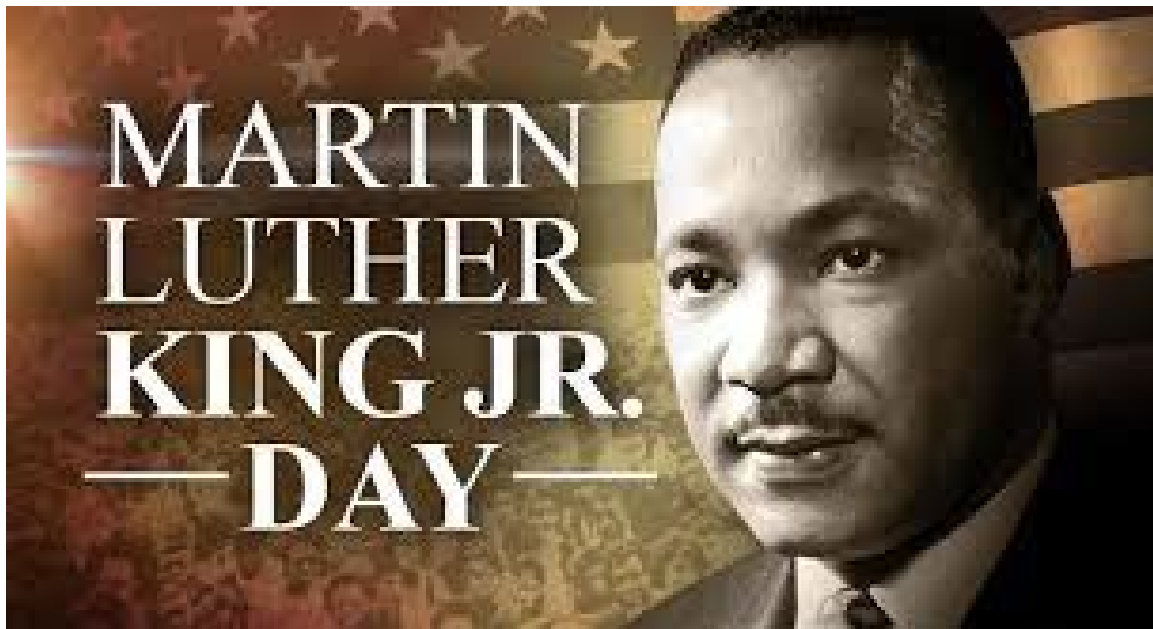

Preventing Snow Shovel Injuries

Dos:

- Dress in layers
- Stay hydrated
- Pre-treat with salt or ice-melt before it starts snowing
- Shovel only fresh powdery snow
- Shovel a few times during and then after a major snowfall
- Push the snow rather than lift it
- Use an ergonomically-designed snow shovel

Don'ts:

- Shovel after eating a heavy meal
- Smoke cigarettes before, during and directly after shoveling
- Rush, instead take frequent, 15-minute breaks
- Lift the heavy snow shovel with your back
- Throw the snow over your shoulder
- Leave a snow blower running while unattended

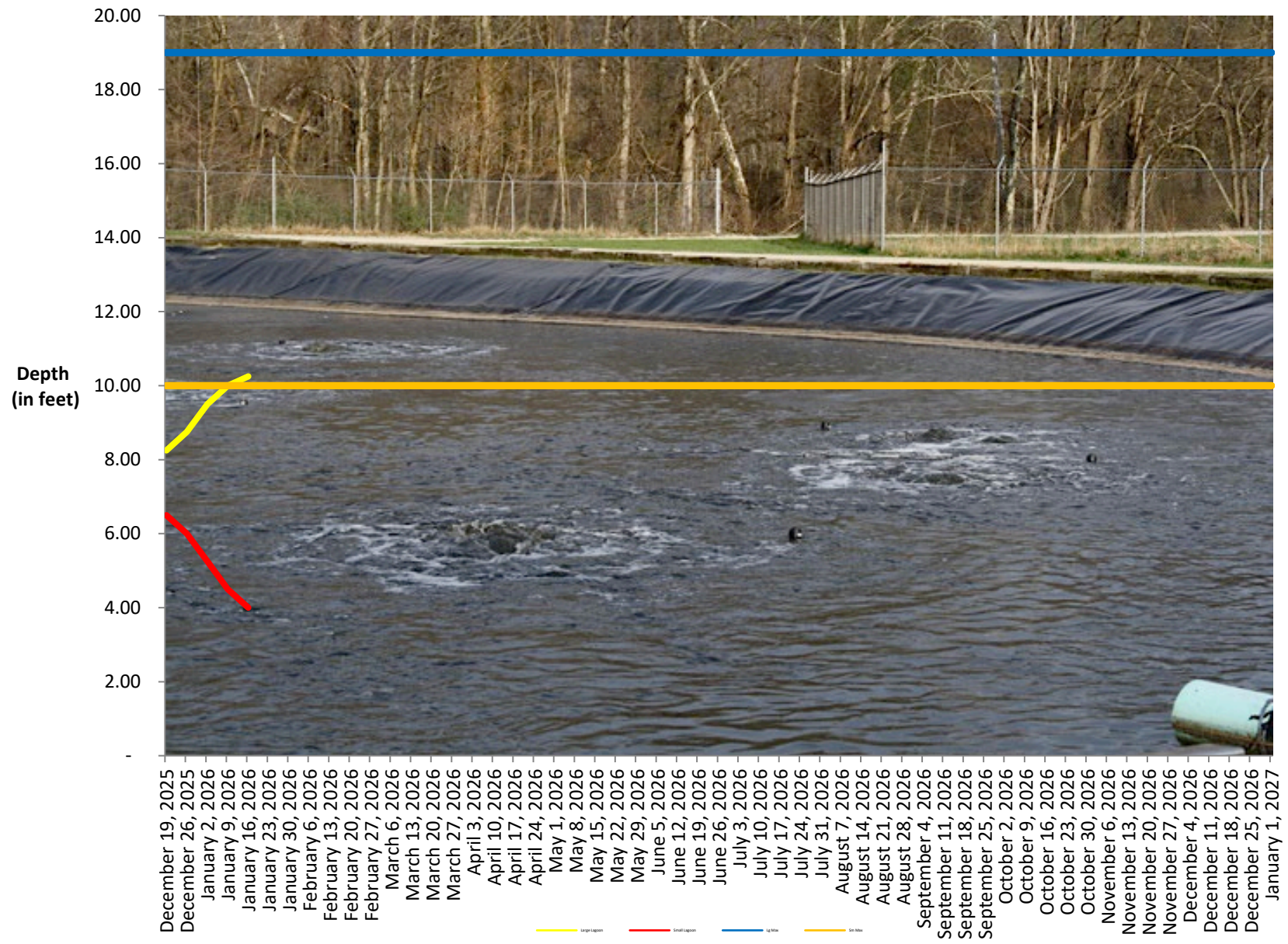

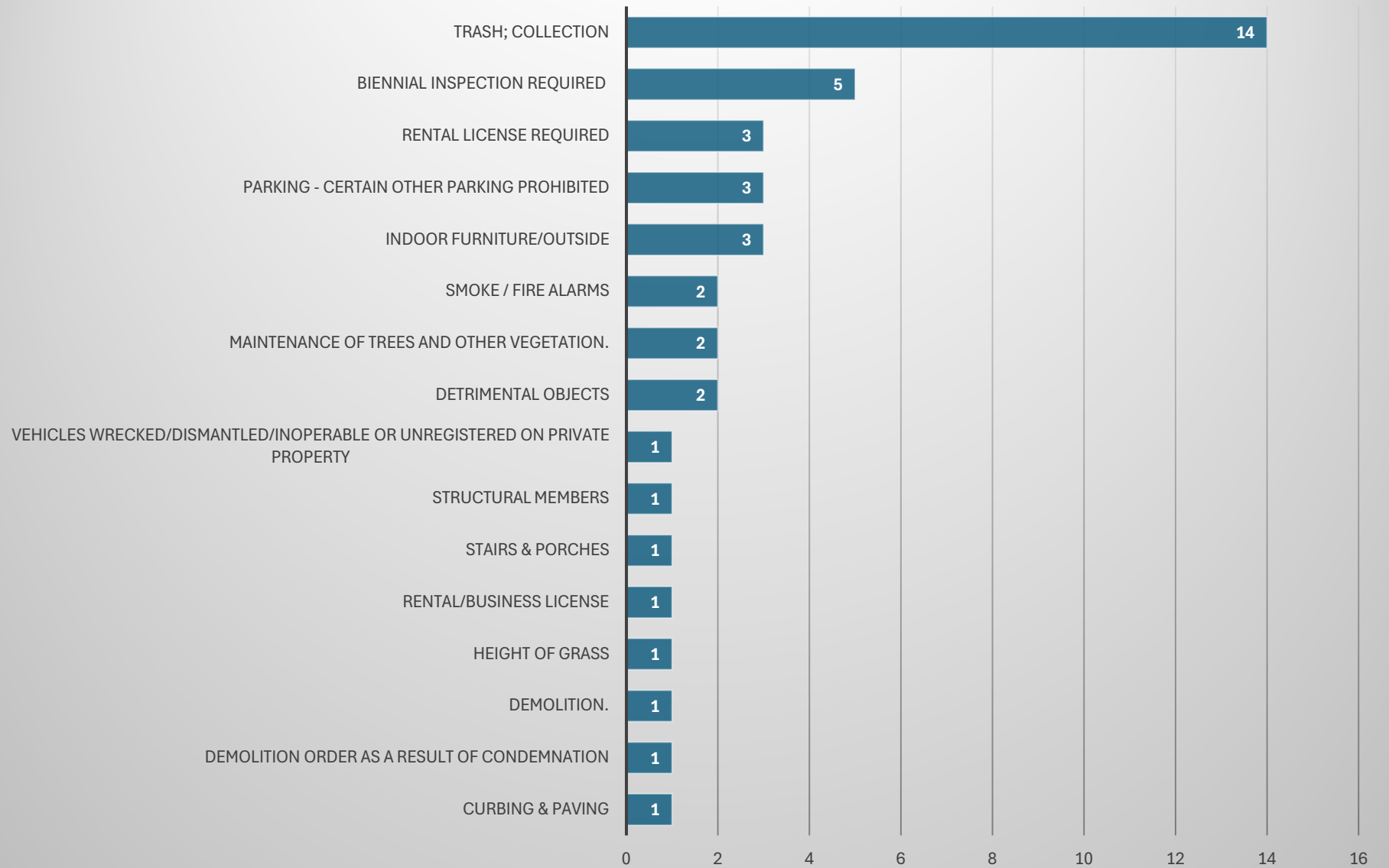

January 9, 2026 to January 15, 2025

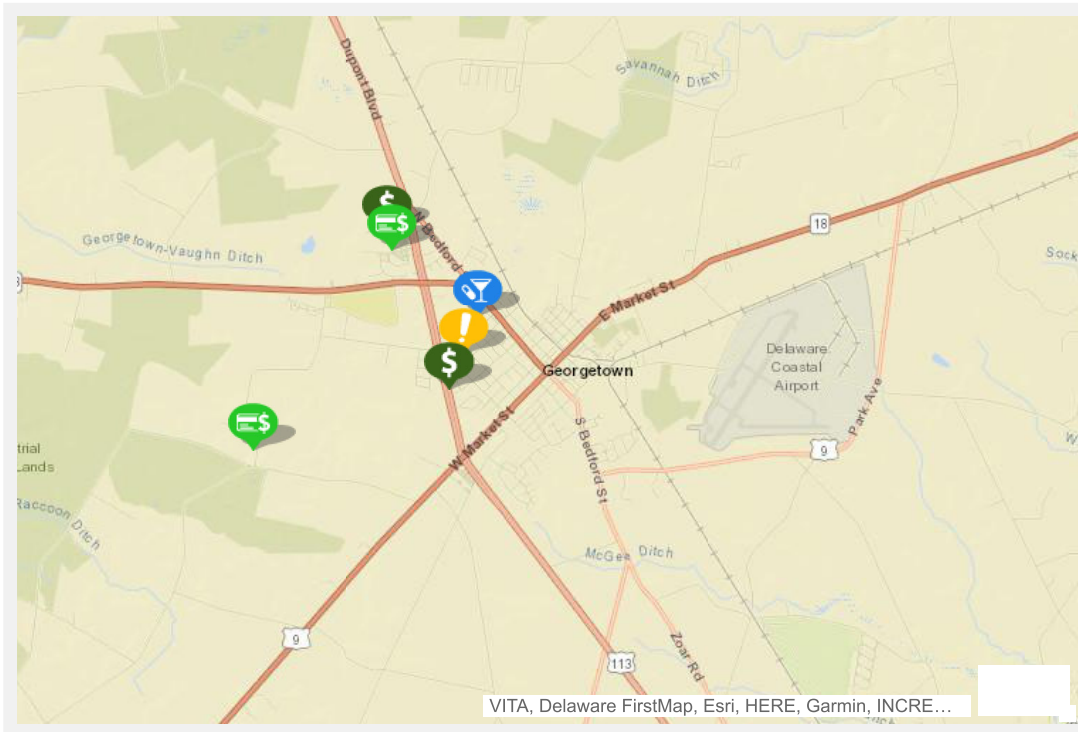

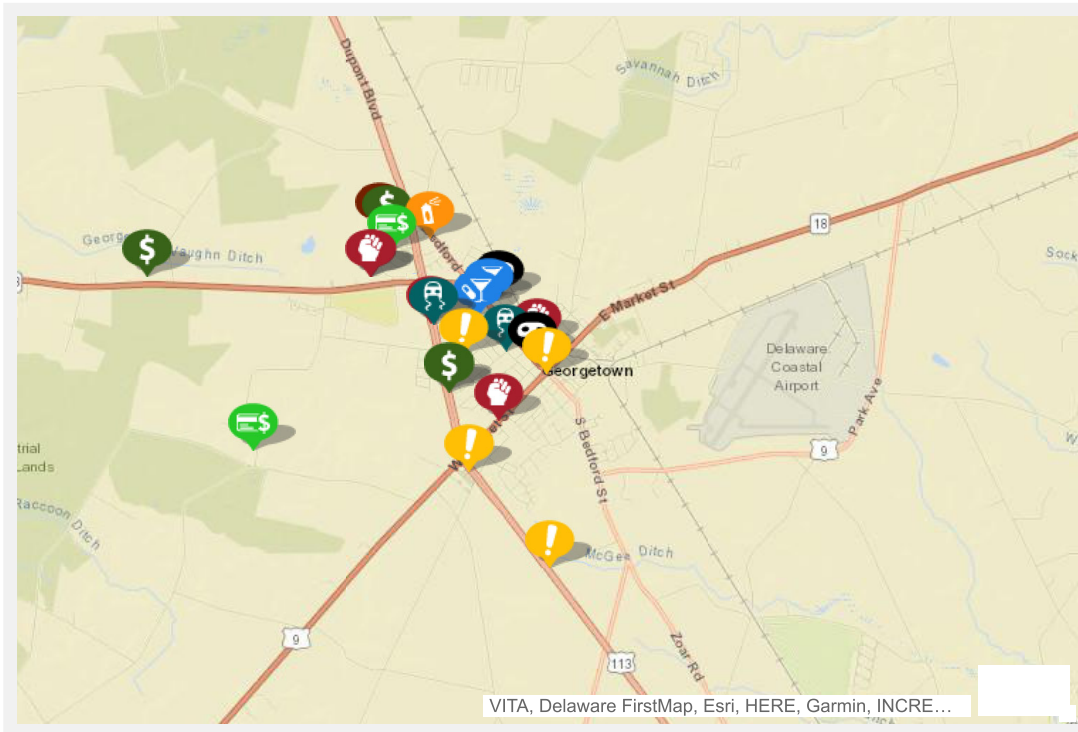

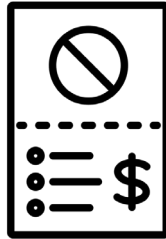
