

### Project Overview, Civil Approvals & Site Development

#### **Overall Status:**

- Construction planning for the Police and Public Works facilities continues in line with the established phasing plan.
- Architectural drawings remain complete, with final coordination underway among design, civil, and utility partners.
- Town, developer, and civil engineers held working sessions to address comments and refine drawings; updated packages are now in circulation for review.
- Coordination with multiple reviewing agencies remains active to keep the project aligned and ready for the next phase of work.
- Focus continues on maintaining progress and aligning final approvals before the winter construction window.
- Weekly meetings remain ongoing with town stakeholders to review design and site development milestones.

### **Building Design Progress**

#### **Police Facility:**

- IT and dispatch technology integration discussions continue with town vendors.
- Interior layouts and furniture selections advancing through vendor coordination.

#### **Public Works Facility:**

- Generator and electrical planning refined; final options are under consideration.
- Mechanical, electrical, and plumbing systems integrated into the current design package.
- Equipment layouts and mezzanine storage area has been further detailed.

## **Technology & Security Coordination**

#### **Technology & Security Coordination**

- Coordination between IT and security vendors remains ongoing, with emphasis on integrating server room infrastructure, low-voltage systems, and access controls.
- Scope and budgeting discussions advancing to ensure all systems align with town expectations and long-term technology plans.
- Design teams continue cross-reviews to finalize drawings and maintain consistency across both facilities.

### Procurement & Long-Lead Planning

### **Procurement Monitoring**

- Bid requests issued for initial site packages and early work.
- Monitoring long-lead materials closely and planning procurement alongside construction progress.
- FF&E selections continue, with interior and casework integration under review.

# Traffic & Permitting

#### **Coordinated Review with DelDOT**

- Updated traffic study and related documents submitted to transportation agencies;
  record plans remain under review.
- Subdivision approvals received, and coordination continues to finalize any follow-up items.
- Ongoing collaboration ensures traffic and permitting elements align with the overall project schedule.

### **Utilities Coordination**

### **Coordinated Review with Utility Vendors**

- Electric service coordination progressing with the utility provider and regulatory agencies to confirm service area and application details.
- Gas and electric design parameters being finalized to support future building systems and generator planning.
- Continued communication among developer, engineer, and town to ensure timely alignment of service installations.
