C. GEORGETOWN PUBLIC LIBRARY (\$30,000.00) – APRIL 12, 2022

Rachel Culver, Director of the Georgetown Public Library, presented to Council how the \$30,000.00 from the GREAT Fund was used.

D. SANDHILL FIELDS (\$25,000.00) – MAY 24, 2022

Town Manager Dvornick read into the record what was provided from the General Manager of Sandhill Fields on how the funds were spent.

7. GRANT FUND RECIPIENT REPORTS – GEORGETOWN EMERGENCY SERVICES FUND

A. AMERICAN LEGION AMBULANCE - STATION 93 (\$100,000.00) - MAY 11, 2022

Gary Morris, Manager of the Georgetown EMS, provided in writing a description of how the funds are planned to be spent.

Mr. Morris requested permission from Council to use the \$50,000 balance from the money granted in May 2022 and use it for renovations to their existing building. The reason for this change is because Station 93 was able to receive additional funding from other agencies to pay for the new ambulance in full. No additional money is being requested form the GREAT Fund. Town Solicitor clarified that this was not a request for new funds and Mr. Morris confirmed.
