Grievance re: Termination of Edgar Verde - alleged violation of CBA §2.02; 6.01; 13.02

Michael Coviello, attorney representing Edgar Verde, presented his argument on behalf of Mr. Verde's case to Mayor and Council:

- Arrested for DUI; Case dropped by State Attorney.
- Spoke in reference to Mr. Verde's career as a police officer.

Town Solicitor Stephani Ballard

- Asked if anyone wanted to make any contractual arguments
 - o Michael Coviello spoke in reference to the timeliness matter of this grievance.

Town Manager Dvornick

- Question for Mr. Verde regarding his notice of termination informing him of his right to request a meeting with the Town Manager?
 - o Mr. Verde: Did not request this meeting
- Cited a section from Town Code Chapter 29 section 46 C-3, requiring that all drivers for the Town hold a valid license. They also must be insurable.

Dean Rubino, Insurance Market Account Executive

• Spoke in reference to matters regarding the grievant having a valid driver's license and whether or not the grievant is insurable.

- He was not comfortable when Officer Goins contacted him directly with vague questions about this matter and wanted to make the Town a part of the conversation
- Questions/Comments posed from Council.
