6. TOWN SOLICITOR COMMENTS REGARDING CODE OF ETHICS AND PROCEDURES

Responded to comments made at the previous Town Council meeting regarding the Code of Ethics and procedures, and the Town Solicitor's role.

- Stated she was not one of the attorneys paid by the Town in connection with the Ethics Commission hearing, which originated with a citizen complaint
- The presence of two attorneys is standard practice one presents the case and one advises the Commission
- Clarified the presenting attorney does not represent the complaining party
- Clarified that her job as Town Solicitor is to provide advice to the Council as a whole, in the best interest of the Town. The Solicitor does not control the client's actions or direct the votes of any Council member. It is the Solicitors job to assist Council with understanding the legal issues that come before them
- As to Ethics, each Councilmember is differently situated as to potential conflicts, and is responsible for his or her compliance with the Code of Ethics.

- If asked and given details about a situation, the Solicitor can and will advise a Councilmember as to Code of Ethics, but again cannot direct the Councilmember's vote. It would be inappropriate for the Solicitor to challenge the ethics of a Councilmember
- Advised she was not asked for opinion or advice prior to the actions which were the subject of the recent hearing
