Affordable Connectivity Program

The Affordable Connectivity Program provides eligible households \$30 per month toward high-speed home internet service, making some plans FREE! The ACP benefit can be applied to a new or existing internet plan.

Additionally, eligible households receive a one-time discount of up to \$100 to purchase a laptop, desktop computer, or tablet from participating providers if they contribute \$10-50 toward the purchase price.

WHO IS ELIGIBLE FOR THE ACP BENEFIT?

Your household qualifies for the Affordable Connectivity Program if

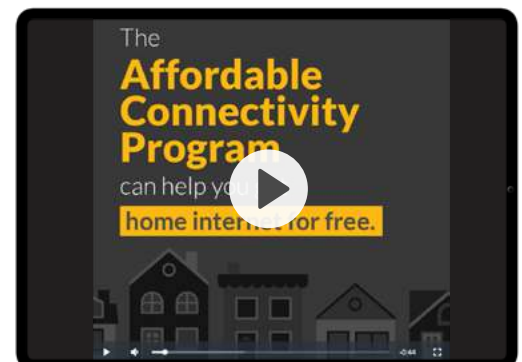
- your total income is at or below 200% of the federal poverty guidelines
- OR
- if any member of the household:
 - Participates in certain assistance programs, such as **SNAP, Medicaid, Federal Public Housing Assistance, SSI, WIC, or Lifeline;**
 - Received a **Federal Pell Grant** in the current award year;
 - Received approval for benefits under the **free and reduced-price school lunch program or the school breakfast program**, including through the USDA Community Eligibility Provision (CEP), in the current or previous school year; or
 - Meets the eligibility criteria for a participating provider's existing low-income program

Only one monthly service discount and one device discount is allowed per household.

[Program rules](#) acknowledge there may be more than one eligible household residing at the same address. In cases where only one fixed connection can be purchased at a given address, but two households reside there, the second household can purchase a mobile plan to receive their ACP discount.

HOW DO HOUSEHOLDS APPLY FOR THE BENEFIT?

There are three ways to apply for ACP benefits:

1. Visit affordableconnectivity.gov to submit an application or print out a mail-in application.
2. Contact your preferred internet service provider directly to learn more about the application process.
3. Complete the [application](#) and Household Worksheet and mail them, along with copies of proof documentation, to:

 - *Note: Mail-in application may take several weeks to process.*

SELECT THE BEST INTERNET PLAN FOR YOUR HOUSEHOLD

How many people will use the internet?

When more people share the same connection, a faster plan is needed to accommodate their devices.

How will you be using the internet?

Downloading is when the internet shares information with your computer. You'll need higher download speeds when watching Netflix and online gaming, than if you only surf the web, use social media, and do online shopping.

More day-to-day activities also require the fastest upload speeds (when our computers share information with the internet) e.g. Zoom and video/audio calls, online gaming and sharing photos on social media.

High-speed home Internet allows Americans to work remotely, send their children to school, participate in the social safety net and access healthcare, job training, and critical government services. The [Affordable Connectivity Program \(ACP\)](#) is a federal benefit that aims to connect these individuals by providing eligible households with a discount of \$30/month toward their home Internet bill or \$75/month for households on Tribal lands. In addition, the benefit provides a one-time \$100 discount toward a connected device through a participating provider.
